Note: Your child is eligible to earn up to \$1000 for college based completion of the Incentive Award requirements.

Active membership requires the following:

- Submit Parent Permission Form (A-1) to MESA Advisor.
- Submit Student Profile Form (A-2) to MESA Advisor. Student information will be entered into MESA Information Management System (MIMS).
- Attend MESA meetings, minimum of 10 per year.
- Participate in tutoring sessions, minimum of five per year.
- Participate in MESA activities and competitions, minimum of two per year.
- Demonstrate a high standard of behavior while participating in NM MESA events.
- Earn C's or better in math, science and English classes, and maintain an overall GPA of 2.0.
- **MESA students that participate in illegal activities such as, but not limited to, possession or consumption of alcohol and/or drugs, theft, or vandalism, relinquish their current and future membership in NM MESA, Inc.**

HIGH SCHOOL INCENTIVE AWARD GUIDELINES (IA)

MESA members *must* complete the following requirements to be eligible for the Incentive Award:

- Submit Parent Permission Form (A-1) and Student Profile Form (A-2).
- Complete Senior Profile information in MIMS
- Participate in a **minimum of 12 tutoring sessions** per school year.
- Attend a **minimum of 18 MESA meetings** per school year.
- Participate in a **minimum of one MESA service learning activity** per school year.
- Complete **4 credits of college preparatory math, science and English** upon high school graduation.
- Provide a social security number or green card number

Please note the following:

- Members who do not meet **ALL** of the IA eligibility requirements each year are not eligible for an award for those respective school years.
- **Active membership junior and senior year is required** for students to receive an award.
- Member and parent/guardian agree that NM MESA, Inc., is the final authority on Incentive Awards.
- Member's grades and test scores are verified by an official high school transcript.
